The **FETF Conference at the Capitol** was a great success. On June 18, 2011, a group of 77 parents, siblings, guardians, caregivers and self-advocates who receive services from DDS gathered in the Old Judiciary Room of the Connecticut State Capitol Building to plan specific actions for the coming year. Families proposed twelve distinct projects for the FETF. Communications with families, residential services, transportation and employment were identified as most important. The Family Empowerment Task Force (FETF) is an informal, unincorporated, organization of parents, siblings, guardians, caregivers and self-advocates that works to sustain, enhance and grow the Home and Community Based Services (HCBS) that are offered by DDS through its private provider network by: 1) Developing a supportive network of families and individuals who receive services; 2) Educating families about DDS services; and 3) Educating legislators and public officials about the needs of families.
