The 2012 elections maintained the **political status quo in our state government**. There are a few new faces in the legislature but the same party is in control of both chambers by the same count and the same executive management team is in place. Now is a good time to contact your state legislators and alert them to your situation. Connecticut is currently facing a \$365 million shortfall in the budget for the current fiscal year that will require **immediate cuts in state spending**. The General Assembly is expected to convene for a special session in December to consider a deficit-mitigation plan. Across-the-board spending cuts could mean significant reductions in the DDS budget for January-June 2013.

The 2013 General Assembly will produce a **new biennial budget for FY 2014 and FY 2015**. The state is facing deficits of \$1.18 billion in FY 2014 and \$0.96 billion in FY 2015. That's about 5% of the entire general fund – so we must be prepared to fight proposals for significant budget cuts in DDS. In previous memoranda regarding the impacts of such cuts, Commissioner Macy has said that the extent of such reductions are unprecedented and they would touch every facet of DDS services including services to the most vulnerable.

**Public Act No. 12-33** authorized the Service Employees International Union (SEIU) and the State of Connecticut to negotiate a collective bargaining agreement for self-directed Personal Support, Individual Home Supports, Individual Day Supports, Respite, Adult Companion, and Transportation among others. If you self-direct these services then your interests are represented by a Personal Care Attendant Workforce Council. The Act requires the Council to meet by September 1, 2012, to establish standards for wages, benefits and conditions of employment, however the Council has not yet convened any meetings nor issued any recommendations. Meanwhile the SEIU has surveyed our workers and prepared their position.

DDS is developing **new individual budgets and service rates for residential services at private providers** based on a person's level of need in accordance with the Legislative Rate Study Final Report. Earlier this year, the DDS South Region held a series of **forums about Creative Housing solutions** where families shared innovative residential arrangements in lieu of group-home placements for their adult members who live with intellectual disabilities. ## Upcoming Events

State legislators will convene for a **special session during the week of December 17, 2012** to consider a deficit-mitigation plan for the current fiscal year.

The **2013 General Assembly** will convene on January 9, 2013. The Governor will deliver his biennial budget proposal to the legislature in early February. Public hearings on the budget will be scheduled in February and March. Stand by for announcements of public hearings on the budget and other matters of concern to families.
