In September families gathered for music, food and sharing at the **FETF picnic at Hammonasset Beach State Park**. DDS Commissioner Macy made a surprise appearance and personally spoke with each and every family there.

The administration finally achieved a budget agreement that avoided the implementation of drastic "Plan B" reductions to DDS funding, however the Department has disclosed potential **midterm budget reductions** that total \$48 million in FY 2013. The largest proposed decreases are \$24 million in private provider residential services and \$10 million in private provider day services. These cuts would be included in the Governor's prospective midterm budget adjustments.

***Now is the time to contact the Governor and your state legislators and ask them to support a larger budget for private providers at DDS!***

The **Program Review and Investigations Committee** is completing its investigation of the Provision of Selected Services for Clients with Intellectual Disabilities. This investigation follows earlier studies by OPM's Commission on Nonprofit Health and Human Services and the legislature's Advisory Committee that studied the impact of the shift from Purchase of Service contracts to attendance-based, fee-for-service reimbursement at DDS. The current investigation will compare the cost of providing public and private services to determine the most cost-effective means to deliver those services.
