Commissioner Macy posted an explanation of the **FY2013 budget rescissions** at DDS. Most of the cuts are in funding for private agencies - so ask your agency for more details. Other cuts are in non-waivered self-directed services such as community activity fees. Read DDS budget updates : <http://www.ct.gov/dds/cwp/view.asp?a=3&q=433828>

The **Governor unveiled his budget proposal for** FY 2014 and FY 2015. DDS Employment and Day Services for adults are **funded about 1.6% BELOW the projected costs** of current service levels. Residential Services are **funded about 2.7% BELOW the projected costs of** current services. Funding is reduced for residential placements to encourage an increased use of various in-home supports such as family support grants and respite programs for new and existing DDS clients. Other savings will be realized through a review of group home and residential center placements for consolidation opportunities. Additionally, family grants and/or individual budgets will be analyzed to ensure payment amounts are appropriate. The reduction also reflects the transfer of Supportive Housing Funding to the Department of Housing to fund Rental Assistance Program certificates that will be used to develop an appropriate supportive housing model for individuals with intellectual disabilities served by DDS. The Governor also proposed a new **\$20 million** state bond pool **to help nonprofit service providers** pay for infrastructure improvements.

HB 5171 AN **ACT CONCERNING PUBLIC HEARINGS FOR GROUP HOMES**, which is in the Planning and Development Committee, would subject individuals who live with intellectual disabilities to public hearings if they create a community living arrangement with support from DDS.

HB 6001 AN ACT CONCERNING RESIDENTIAL COMMUNITIES FOR YOUNG ADULTS WITH DEVELOPMENTAL DISABILITIES would create segregated residential facilities for young adults.

Several other bills propose to interfere with DDS operations:
HB 6005 AN ACT CONCERNING A MORATORIUM ON THE CLOSURE OF GROUP HOMES.
SB 129 AN ACT CONCERNING THE HARTFORD REGIONAL CENTER OPERATED BY THE DEPARTMENT OF DEVELOPMENTAL SERVICES.
HB 5267 AN ACT CONCERNING THE REGIONAL DELIVERY OF SOCIAL SERVICES.
SB 593 AN ACT CONCERNING LOCAL ADMINISTRATION OF SOCIAL SERVICES.

- Identify yourself.
- Identify the bill that you are addressing.
- Clearly state your position "for" or "against" the bill.
- Summarize.
- Bring copies.
- Remember that ordinary citizens brighten legislators' days!
